**CALL TO ORDER/WELCOME**

Ms. Suzie Razmus, Secretary, called the Regional Transportation Committee meeting to order at 10:34 a.m. Quorum was present.

**APPROVAL OF MINUTES**

Mr. Howell Holbrook moved that the minutes be approved as presented. Mr. Shane Gabbard seconded the motion. Motion carried.

**TRANSPORTATION UPDATES/GUEST SPEAKERS**

Mr. Troy Hearn with Kentucky Cabinet for Health and Family Services and Mr. Justin Harrod with Kentucky Transportation Cabinet were the guest speakers for the Regional Transportation Committee meeting.

Mr. Hearn spoke about the State Physical Activity & Nutrition Program (SPAN). The program includes bicycle & walking master plans for different cities and counties. The program works with local health departments and the bicycle/pedestrian program with KYTC. The program works with the planning, design, and construction for walking facilities and making all projects ADA compliant. Mr. Hearn also provided updates on local CVADD plans for the cities of Manchester, McKee, and Mt. Vernon. Mr. Keith Lovan, KYTC Bike/Pedestrian Coordinator told the regional transportation committee about conducting a Main Street Policy & Manual Statewide plan. The plan will be making Kentucky more bicycle/pedestrian friendly across the state.

Mr. Justin Harrod with KYTC provided an update on electric vehicle information. He discussed the electric vehicle overview, federal funding sources, different types of electric vehicles, electric vehicle charging stations, barriers to the use of electric vehicle adoption, Alternative Fuel Corridors (AFCs) and more. Mr. Harrod also mentioned that if

Ms. Eunice Holland, Regional Transportation Director for the Kentucky River Area Development District provided the Annual Work Program Update. The Annual Work Program is an update with KYTC with 30 deliverables in the program. The data is sent to KYTC when completed. The Public Involvement Plan & Regional Transportation Asset Plan has been updated and uploaded to the CVADD website. The Major Freight Users Plan will be updated in FY23.

#### **KYTC PROJECT UPDATES**

Mr. Jeff Dick provided updates on Rockcastle County projects. Mr. Keenan Jones provided updates on HDO District 11 projects in London and Corbin. Mr. Kenny Morgan and Mr. Jacob Huber were not present for Central Office updates.
