CALL TO ORDER/WELCOME

NEW BUSINESS

The Cumberland Valley ADD Transportation Committee met at the new Kentucky Transportation Cabinet (KYTC) Highway District 11 office in Manchester KY. After introductions, Ms. Sherri Chappell provided an update on active transportation projects throughout the district. The discussion covered the status of ongoing construction and infrastructure improvements including the new US-25 widening project from London to Corbin. Also mentioned were current project timelines, and priorities for upcoming work. Committee members had the opportunity to ask questions and discuss project progress, local transportation needs, and future planning efforts.

Following the discussion part of the meeting, committee members received a comprehensive tour of the new facility, highlighting its layout, operations, and capabilities.

Following the meeting and facility tour, committee members gathered for lunch, where discussions continued in an informal setting. Conversation focused on ongoing transportation projects and issues affecting the region, allowing members to further exchange ideas, discuss community concerns, and continue conversations initiated during the project update.
